About Us

Astor Counseling Centers, located throughout Dutchess & Ulster Counties, NY provide counseling, psychiatric services and case management to children and adolescents (ages 2-21) and their families. Licensed by the New York State Office of Mental Health and accredited by The Joint Commission, the counseling center is a designated Child and Family Clinic Plus* provider.

First time clients who would like to be seen at one of the Centers can walk-in between the hours of 9:00 AM and 2:00 PM.

Dutchess and Ulster County Department of Mental Hygiene contracts with the Astor's Counseling Centers to provide specialized treatment services to help children reach their highest potential in family life, school, friendships, and recreation. We do this through an interdisciplinary staff that includes child psychiatrists, clinical psychologists, social workers, mental health counselors, and case managers. These professionals are committed to using their expertise in the best interest of the children and families they serve.

Eligibility & Enrollment Requirements

To be eligible for Astor Counseling Services, the youth must:

- 1. Reside in Dutchess or Ulster County
- 2. Be between the ages of 2-21
- Have a mental health concern that interferes with one's own life, the family's life or life within the community.

How to Obtain an Intake Appointment

In Dutchess, Families can call Helpline (485-9700) for information on Open Access hours and the location of the nearest Counseling Center. An appointment can be made by calling the counseling center directly.

"Walk-ins" are welcome during the hours of 9:00 AM – 2:00 PM and can wait for the next available intake appointment.

* Child and Family Clinic Plus provides mental health screenings in public schools with follow-up treatment when it is determined advisable.
