It is not what you think!

It's actually just a marketing ploy, a clever, memorable name for an affordable fishing rod. However, in the hands of Griffin, one of our children at the residential treatment center in Rhinebeck, it's a mark of normalcy: a souvenir of childhood, like old football helmets, Legos, and in-line skates.

It is a wand to claim a bit of a Huckleberry Finn Summer. Griffin proudly showed his Ugly Stick, with all the excitement only a kid can muster, for an extruded piece of plastic. But in his hands, it's a wand to lure the rainbow trout from their eddies and claim his small chunk of a wonderful summer.

As you look around Griffin's room, it could have been any kid's, anywhere. But this room was lit with his joy at spending a balmy summer in the Hudson River Valley and decorated with his trophies of fun. He talks about his love of fishing and the catch he had snared. Although Griffin has mental health challenges, you realize he was telling and showing us something we too often forget: the children that we serve are basically and fundamentally just kids. The overarching goal of Astor is to give them – to guarantee them – the childhood they so well deserve. This is what we give the children who come into our care: the simple joy of a child like Griffin and his Ugly Stick. We want each of our children to delight in the summer and be able to experience the simple everyday pleasure of being a child!

There was one child in our Residential Program in Rhinebeck whose behavior was unpredictable. Although he was apprehensive at first to even pet Lina, one of the therapy dogs, now he waits every week for her arrival.

Lina's presence helps him feel more relaxed and open to talking. During group sessions with Lina, staff are able to introduce and discuss topics the children can relate to, but that are not directly focused on their lives. For example, they might discuss what it means to be a "rescued dog."

Nathaniel, a beautiful, kind, three-year-old in our Head Start^{*} program, is in foster care after being abandoned by his family. He was extremely shy. He also had a lot of anxiety and fear when he came to us. Our teachers and family advocate worked both with Nathaniel and his foster mom to address his issues.

After the care, love and support Nathaniel and his foster mom received, he is now ready for Kindergarten. Nathaniel will soon be adopted by his foster parents and is a happy, confident preschooler.

One day during class, his teacher went around the room and asked the children why they were special. Nathaniel replied, "Because my (foster) mother loves me!" 
