### IN THE HUDSON VALLEY

### IN THE BRONX

This past holiday season the Metropolitan Transit Authority (MTA) once again provided each child in Astor’s Day Treatment Program in the Bronx, with an individualized, wrapped holiday present that was distributed at each site by Santa. For the past eight years members of the MTA union have been providing our kids with gifts through their Toys for Tots program. Santa and his cadre of elves visited each of Astor’s three sites delivering over 175 presents. After the gift distribution the children thanked Santa and the elves and everyone shared juice, cookies and a song or two. This is a very exciting day for the children. We are very thankful to the MTA for their continued support!

## BRONX CLINIC PROGRAMS TAKE CULTURAL SENSITIVITY AT ASTOR TO A NEW LEVEL

Astor is committed to cultural diversity and sensitivity and to meeting the needs of all our clients. In February 2007, Astor assigned February as Cultural Sensitivity Month; when staff in each program area may set aside time to focus and assess how this issue is being addressed. Some program areas spent time reviewing articles and books and then engaging in discussions. Here is an example how one group in the Bronx programs took this mandate to a higher level...

The clinical staff of the Bronx outpatient clinic programs developed a successful series of focused discussions on the topic of cultural sensitivity. This series emerged out of the narrative therapy readings that June Helme, LCSW-R, Clinical Director of the Tilden Clinic, presented last February. June was particularly attuned to *We Are Making History Now* by Vanessa McAdams-Mahmoud, published in *The International Journal of Narrative Therapy and Community Work* (2002 No. 2). This work makes use of African American slave narratives in the collaborative therapy of young black college women in order to support and sustain their efforts to disengage

from and stand against oppression in their own lives. Similarly, June also chose to read Puerto Rican folks tales that stimulate therapeutic multigenerational conversations. June shared these articles with staff who agreed to meet and discuss their reactions to the articles. This experience launched a cultural diversity series. Staff members were so impressed by the messages conveyed in these articles that they agreed to continue meeting. The series has now become a very popular and important forum for the clinical staff that continues to expand and provide opportunities for growth and understanding. As a result, the Highbridge clinical, preventative services program and office staff have now joined the series. One member said “I’m thankful for the opportunity for dialogue about culture on a group level, with regularity. Many of us have taken emotional risks in our sharing during these discussions, which seems to be key in taking our dialogue past generic observations about ‘the culturally different’ and on to the real struggles we face in negotiating our identities in the therapy room.” This series has now begun its second year as Astor continues making history!
