RHINEBECK, NEW YORK, January 12, 2017 – Prominent television news reporter Magee Hickey and the Hickey family proudly present 'It's a Good Day,' a fund-raising tribute to the legendary Peggy Lee, as sung by cabaret singer Stacy Sullivan, on Saturday, February 4, with proceeds to benefit children of <u>Astor Services for Children & Families</u>' Lawrence F. Hickey Center for Child Development in the Bronx, New York. The center provides early childhood and mental health services to 3-to-5-year-olds with emotional and cognitive challenges.

With this seventh annual Cabaret fund-raiser, Hickey continues the legacy of support to Astor's children by her father, Lawrence Hickey, for whom the Hickey Center (formerly the Little Red Schoolhouse) was named in honor of his integral work in establishing the center and support of Astor's children.

"My father was a kind, loving, generous man who believed every child deserved the best possible start in life," said Hickey. "Lawrence Hickey, father of four and grandfather of eleven, worked for decades with the Children's Foundation of Astor to develop therapeutic programs for special needs preschoolers in under-served communities in the Bronx. He was so touched when Astor named the Little Red Schoolhouse on Dyre Avenue in his honor. And now, in the five years since his passing, it is his children's pleasure to raise funds for the Lawrence F. Hickey Center for Child Development."

The Saturday, February 4 event, will take place at the Sheen Center, 18 Bleeker Street, New York, New York. A VIP reception is scheduled for 6 p.m.; the show will begin at 7 p.m. Tickets are \$75 for general admission and \$150 for orchestra seats and the VIP reception.
