Why a potential STAR rebate change is causing angst among homeowners

LBANY - State lawmakers are criticizing a proposed change to the state's popular STAR program that would expand who gets checks rather than upfront savings in homeowners' school tax bills.

In his state budget proposal last week, Gov. Andrew Cuomo recommended that New York send STAR checks to all homeowners who earn \$200,000 a year or above. They have been receiving the exemption upfront in their school tax bills since the program's inception in the mid-1990s.

The move comes after the state Legislature and Cuomo agreed last year to switch everyone with an adjusted growth of the check.

"It's already a nightmare," Sen. Pete Harckham, D-Yorktown, Westchester County, said.

"The number one complaint I get in wyoffice is from constituents reading."

"The number one complaint I get in my office is from constituents regarding the STAR program. So to further exasperate those problems, is nather than streamline and have a solution to those problems, is very fustratting."

About 3 million New Yorkers get breaks each year on their school property taxes through STAR, averaging about \$800 a year. It is available on homeown-

Cuomo's proposal is his latest at-tempt to tinker with the STAR program as a way to move it from the state's ex-pense side of the ledger to the revenue side.

East Fishkill Fire District sues truck's builder

In mid-January 2015, the East Fishkill Fire District received the fire truck it purchased for more than a million dollars from a Louisiana-based company, Ferrara Fire Apparatus.

Within two months, the district began experiencing problems using the truck's bucket. About a month later, the district noticed the truck's check engine light had turned on. Around two months after that, the truck needed to be shipped to Nebraska for the installation of other repairs, after conferring with Ferrara.

In the past five years, the truck has needed to be repaired more than 20 times, making it unavailable for the numerous mechanical failures for approximately one calendar year."

All of that is according to a lawsuit the East Fishkill department has filed against Ferrara, claiming the truck has been defective all along.

The complaint was filed in U.S. District Court Southern District of New York on Wednesday. The department is seeking the original price it paid + \$1,002,351 - plus interest.

Representatives of the East Fishkill Fire District declined comment. Attempts to reach Ferrara Fire Apparatus were unsuccessful.


Another lawsuit aims to prevent an Amazon warehouse in region

Choice Words' clients win \$4.87 million in NYS funding for 7 Hudson Valley projects

New Paltz-based Choice Words LLC handled the grant writing for seven projects that received \$4.87 million in collective funding via the New York State Consolidated Funding Application (CFA). The awards will help fund development, infrastructure, and capital improvement projects for companies, municipalities, and nonprofit organizations located in Dutchess, Orange, and Westchester counties.

Arthur May redevelopment advances with town approvals

Moving forward a development that will transform Poughkeepsie's Arlington Town Center, Arthur May Redevelopment, LLC, (AMR) an affiliate of Poughkeepsie based PAZ Management, Inc., will redevelop the former Arthur S. May Elementary School located at 25-31 Ray-
