

Yvette Bairan officially took the helm as Chief Executive Officer (CEO) on January 6, 2020, after having served as interim CEO since July 2019. Also, Therese M. Lack, Ph.D., who joined Astor's Board of Directors in 2015 and was elected Board Chair in 2020. Both took on new roles during the pandemic. Within two months of assuming leadership roles as CEO and Board Chair, our country would be thrown into some of its darkest days as we would encounter a worldwide pandemic coupled with racial unrest and political upheaval throughout the country.

We are proud to say that in the midst of all of this, Astor's employees quickly "shifted" and collaborated with the full support of the Board, to continue providing mental/ behavioral health, educational, and other supportive services to meet the needs of the children, adolescents and families we serve.

Within the first few days of the pandemic, Astor moved over 500 employees to remote work and transitioned to tele-mental health services, which was a smooth shift because we had systems in place to do so. We have been providing telemental health services since 2016 in the Bronx and were well-positioned to expand to the Hudson Valley. The loosening of government regulations regarding tele-health services during this time enabled us to quickly move all of our Outpatient Counseling Centers to this model. In addition, we were able to quickly accept new clients and immediately implemented a Client Hotline (1-866-ASTOR01). This hotline is open 24-hours per day and is monitored consistently.

During this time, true heroes emerged. Armed with personal protective equipment provided by Astor and adhering to all safety protocols and regulations, our employees in the Residential, Crisis, and Prevention programs continued to work directly with our children at the residence and out in the field.

While all this was going on, we continued communications with families, staff, funders, legislators and colleagues. We gave employees the space through our Diversity, Equity, and Inclusion Advisory Committee to discuss and advise us on the racial, social, and political issues impacting them and clients, especially around the intersection of COVID and poor health outcomes (and all the social determinants of health) and race. We acted upon recommendations, which included training opportunities on these issues.

Twenty-twenty has proven that we as an organization, a community, and a country are resilient. It reaffirmed that the high-quality services we provide and our family-driven care philosophies (parents/guardians are integral part of a child's care) are truly impacting the over 10,000 children and families we serve.

We continue to be in awe of how our employees, Board, parents, funders, and supporters all band together to help us through this time and ensure our services are available for years to come. We are proud to say, we have emerged stronger than ever.

Through a wide variety of premier quality education and mental health services, Astor provides support for preschoolers, children with behavioral and emotional health problems, children at risk of placement in foster care and families that need assistance in developing the skills necessary to raise their children in an environment filled with increasing challenges. Astor currently serves approximately 10,000 children each year through its prevention, early childhood, special education, community behavioral health and residential treatment programs.

TELE-MENTAL HEALTH AND FAMILY-DRIVEN CARE

During this unprecedented year, our Outpatient Counseling Centers converted to tele-mental health services within days of the pandemic! In addition, we were able to provide more seamless tele-mental health services for the children and families in our Day Treatment and Partial Hospitalization programs due to clarifications and guidance from our regulators. As a result, we were able to provide over 35,000 tele-mental health services since the beginning of the pandemic (March 15, 2020 - June 30, 2020).

Astor has always engaged in Family-Driven Care. During this time of providing tele-mental health services, this was an important component. Family-Driven Care recognizes that the family is the primary support system for the child. It creates a culture that supports the child's successful development. By engaging and integrating the family as active partners, it empowers and strengthens the family's voice in the treatment of the child. Many families actively participated during tele-mental health sessions.

Sometimes in the midst of doing our work, we do not always know the immediate impact we are making on lives. On Friday, April 3, 2020, a parent reminded us of just that, when she reached out to us, unsolicited, with the following message. It was a reminder that we are indeed making a difference during this time. After about 18 months of Outpatient therapy in Rhinebeck and patiently awaiting a psychological appointment for our daughter, we finally have one on 4/6/2020. In the midst of this pandemic, your response to allow for remote services has left our family feeling better supported in helping our child with her anger and frustration. [Her therapist] has been wonderful, working to support our child, responding to our concerns and escalating/following up on my advocacy requests. While [my child's] diagnosis remains unconfirmed, we feel like we have a neurologist, therapist and soon a psychiatrist who can help us across the continuum. Thank you for working diligently to provide services during this difficult time to so many in need. [Astor Parent]



USING ART TO EXPRESS YOURSELF DURING COVID-19

Knowing the important role the arts can play to help emotionally charged children release their emotions in a productive, confidence-building way, in 2012, we began our Expressive Arts "Paint What You Feel" Program.

This began as an art program for children inspired by Abstract Expressionist artists and their techniques — Jackson Pollock, Willem de Kooning, Brice Marden and especially the squeegee paintings of Gerhard Richter. The program has since expanded, but engages the same principles: giving children, who sometimes do not know how to express themselves verbally, an art form to do so. During COVID, where movements were restricted, children in our Residential Program (24 hours a day, 7 days a week, for children with severe trauma and behavioral issues), were truly impacted by this. Our Expressive Arts Program gave them an outlet to "express" how they were feeling during this very unprecedented and scary time.

Working with a local artist, some of the children engaged in an art project where they were able to express how they were feeling during COVID and their hopes for the future (after COVID).

"It is a great outlet for some of our children who have a hard time verbalizing how they were feeling during this time. The building had to shut down. No one was able to come in or out except for staff. The art project was able to help give them ways to express themselves. It helped keep their anxiety down and gave them hope that we are going to get through this together," said Kathy Mills, PhD, Clinical Director Residential Programs

The children hosted a virtual Art Show showcasing their masterpieces!

Dr. Mills also goes on to say that whether it is music, painting, clay, fashion – all these art forms enable children to express themselves in ways that they can use in therapy to address trauma.

Astor's Cultural Sensitivity and Quality Improvement Team, established over 10 years ago, changed its name to the Diversity, Equity, and Inclusion (DEI) Advisory Committee to better reflect the work of the group. The DEI Advisory Committee has representation from across the organization. The Committee's purpose is to ensure that the services we are providing are culturally appropriate for the clients we serve, and to provide an environment for employees that is tolerant and accepting of all backgrounds, regardless of race or socioeconomic status.

The racial unrest throughout the country magnified the work the Committee was already engaged in. Again, Astor was well-positioned to transparently address these issues that were impacting our staff, clients, and community.

The DEI Advisory Committee, with the support of the CEO and the leadership team, quickly provided opportunities and "safe" spaces for staff to have conversations around the recent racial unrest and protests. In addition, in the vein of being transparent, the CEO held Town Hall meetings and put out statements where these issues were directly addressed. especially the convergence of race and poor health outcomes due to COVID in the communities we serve.

CEO's Statement to Staff, June 5, 2020

As a nation and as a nonprofit organization, we cannot condone racism, racial violence, disparities, or inequality.

The issue of race and institutional racism and its negative impact must be addressed with systematic changes. While it is a huge issue to tackle, I want you to know that at Astor, our Cultural Sensitivity Quality Improvement Team is working in tandem with me, and Human Resources around Diversity, Equity, and Inclusion. This is so important to the health of staff and clients.

There is no tolerance at Astor for racism, prejudices, or any dialogue that condones these behaviors. I expect an environment at Astor where staff and clients are free of racism, social injustices, and all systems of oppression. We all have the right to thrive, live, and work in a safe and equitable environment, regardless of race and socioeconomic background.

I stand with all who are being impacted. As a nation, we can do better and I am committed that within our organization, we will do exactly that!




