Ryan establishes 26-member mental health task force for Ulster County

KINGSTON, N.Y. — Ulster County Executive Pat Ryan has appointed a 26-member task force to identify gaps in the county's existing mental health and substance use disorder services.

The move comes as the county begins to develop plans for spending the roughly \$34.44 million it has been allocated as part of the American Rescue Plan.

Ryan announced the task force in a press release Monday, saying he wants mental health and addiction recovery services to be a top priority in the county's plan for spending the federal stimulus money.

Mental health and addiction services in the county often were at full capacity prior to the <u>COVID-19 pandemic</u>, and the surge in need for mental health and addiction services caused by COVID, plus the removal of inpatient behavioral health beds at HealthAlliance Hospital in Kingston, put an even greater strain on the system, Ryan said.

"At a time when we're seeing more and more of our residents struggling with mental health and addiction, we must step up our investments to meet the moment and take care of each other," Ryan said in the press release. "With much-needed federal relief funds on the way, the Ulster County Behavioral Health Task Force will serve as a crucial mechanism to identify gaps in our existing mental health system and make sure we invest wisely in bolstering our behavioral health programs."

The task force will be charged with creating an action plan based on community needs, which will both highlight existing areas for improvement in the region's behavioral health continuum of care and outline specific recommendations and solutions to address those areas.

The Behavioral Health Task Force will meet monthly from May through September to formulate the strategy, Ryan said.
